Health Officer/Sanitarian Reports:

Ms. Caperino gave an overview of the inspections reported from Bergen County stating that the 2020 inspections have been completed and inperson inspections would start up again in 2021. She then reviewed upcoming education programs for Cervical Cancer Awareness Month as well as Alzheimer's Awarness.

Old Business:

Board Member Askin gave an update on the USRA Coalition.

Mr. Gil confirmed that the rabies vaccination event would be held in the spring due to COVID limitations and outdoor facility issues in the winter months.

President's Report:

Board President Benoit reviewed data off of the COVID19.nj.gov website. She stated that hospitalizations are a very good measure as to how we are doing as a state. Currently there are 3,711 hospitalizations, 430 on ventilators and 654 in critical care. Boardmember Iverson gave an overview of observations that she is seeing in the hospitals.

President Benoit gave an overview of the current vaccine distribution guidelines, plans, and how to register on the state's website. The information would be in included in the January Borough newsletter.

She encouraged everyone to continue the practice the wearing of masks, the social distancing, the hand-washing as well as getting vaccinated.

Board President Benoit and Board Member Iverson addressed a question regarding should someone who has had COVID-19 receive a vaccination and any allergic reactions.

Board President Benoit gave an overview of the Allendale OEM group that is meeting weekly regarding COVID 19 and the positive feedback that has resulted from the meetings.
