A message from Mayor Bernstein. . .

Spring is in the air here in Allendale. As the weather turns from the cold days of winter to the warm days of summer, our DPW is hard at work grooming our sports fields and preparing Crestwood Lake for this season. Another sign of spring here in Allendale is that our Compost Site is now open; you can purchase permits on the Borough's website.

I am excited to announce that Allendale will be hosting a "Spring Cleaning Day" on Saturday, April 23rd. We will be providing a multitude of services to help you start your spring cleaning in an environmentally responsible way. That day we will have paper shredding, electronics recycling, prescription drug take-back, clothing recycling, plastic bag collections, compost machine orders, and a food drive. This event is in coordination with the Borough, our Green Team, and the John Fell House and all the services provided are free of charge. Please take a look at the flyer included in this issue for full details and locations.

Just a reminder, effective May 4, 2022, NJ Law will ban single-use plastic bags at all retail stores, food service businesses, and grocery stores, as well as paper bags at grocery stores at or larger than 2,500 square feet. The law also bans food service businesses from providing polystyrene foam food products. This is a good time to place reusable bags in your car so that you will always have them on hand when running to the store. We have more information on this in this month's Newsletter.

Finally, we all know Allendale is the best, and recently 201 Magazine recognized our downtown as a finalist for their "Best of Bergen". The Borough, especially Council President Wilczynski and Ron Kistner, has been working hard to make our downtown an even more attractive and inviting destination. GARBAGE & RECYCLING REMINDERS

- All items should be put out *starting at 6pm the night before* the scheduled collection.
- Building materials and wood pallets *are not collected* by our garbage contractor. You must make your own arrangements to dispose of them.
- You must schedule a one-time, courtesy move-out pickup with TatianaMarquis@AllendaleNJ.gov at *least 3 WEEKS in advance*. No metal, electronics, or recyclable materials collected.
- Remember to make sure that the lids are securely on top of your cans, especially garbage. This will help keep wildlife at bay.
- Collection containers can be no larger than 30 gallons.
- Bulk Trash must be placed on the curb and **not placed** in the road.
- Food containers being recycled need to be rinsed and cleaned before you dispose.
- Soiled pizza boxes are garbage and **NOT** recyclable.

GARBAGE

- Household kitchen, office and bathroom trash
- Styrofoam

BULKY TRASH

- Furniture
- Carpeting
- Non-metal items
- Windows/mirrors/pane glass must be taped with an "X"

METAL

- Anything that is least 75% metal
- Artificial Holiday Trees

- Junk mail, envelopes, office, notebook, construction paper
- Smooth and corrugated cardboard

- Food and beverage containers
- Plastic containers with a recycling code 1, 2, 5, 7

Stream Clearing Guidance

Recently, the question has been asked, is the Borough of Allendale responsible for the clearance of streams that flow through the Borough on private property or within legal easements?

The answer is no. The Borough of Allendale is not responsible for the clearance of streams that flow through the Borough on private property or easements. Property owners are the parties responsible for the maintenance and cleaning of waterways, which can be undertaken privately, under certain limited circumstances, without the issuance of an NJ DEP permit.

Stream cleaning entails desilting or de-snagging a channel or removing accumulated garbage or debris from an active waterway. It does not entail making a channel deeper or wider than it previously was, as this could result in worsened flooding on properties located downstream of the area to be cleaned. Stream cleaning is a regulated activity under NJ Flood Hazard Area Control Act Rules. These Rules (NJAC 7: 13-7.1 et seq.) generally authorize property owners, under defined circumstances, to remove accumulated debris when such removal can be done without securing an actual DEP Permit. In most instances, debris can be removed without a permit if it does not require the use of heavy machinery.

Recently, the County of Bergen has also issued updated guidance on stream clearing. The County has indicated that certain stream clearing activities may be undertaken by County Mosquito Control agencies only when necessary to control mosquito infestation. To that end, the County will only undertake such operations to prevent the accumulation of stagnant water, thus reducing the need for regular mosquito treatments. Such County assistance is provided only at the written request of municipalities, which must be accompanied by a multitude of engineering and legal requirements, including indemnity and hold harmless provisions.

MESSAGE FROM THE ALLENDALE WATER COMMITTEE

Residents may have received notification from VP/General Manager Alan Whelan, the SUEZ-VEOLIA merger is complete, and they have officially become VEOLIA. We will start seeing the transition to the name-VEOLIA. This does not impact our sale of the Allendale water system to SUEZ/VEOLIA as we have been expecting this change since last summer. Our working team remains the same and SUEZ/VEOLIA remains committed to providing excellent water service as our contract operator currently and as our official water provider once the sale of the system closes. We continue to make forward progress on this process.

On March 24, 2024, the Allendale Council passed Resolution 22-103 authorizing Mayor Bernstein to sign the Allendale Purchase Agreement. The agreement follows a voter referendum that took place in November 2021, in which over two-thirds of Allendale voted in favor of the sale. Final approval is needed from the New Jersey Board of Public Utilities. Closing is expected late summer early fall 2022. SUEZ continues to operate the system through an operations and management agreement with the Borough of Allendale.

Allendale water currently remains in compliance with all NJDEP Quality regulations. SUEZ is fully committed to meeting and exceeding requirements for the removal of PFAS from our drinking water as the EPA and NJDEP introduce new regulations. Levels of PFAS at the existing New Street Wells are near the regulatory limits, Well 11 is currently turned off. The parties have concluded that treatment will be needed prior to completion of the Permanent New Street Treatment Plant and as such the parties have agreed that should the sale of the water system to Suez proceed as planned, Suez shall design, construct, and install temporary PFAS treatment at the New Street Treatment Plant on or before May 5, 2023. If Allendale water exceeds the maximum contaminant limits prior to this time, residents will be notified.

INSTALLMENT PLAN AVAILABILITY

BE ADVISED that State law requires residential customers to be offered an installment plan for any water arrearages accruing between March 9, 2020 and March 15, 2022. To maintain the installment plan, a residential customer must make timely payments on all current charges. More information is available by calling SUEZ/Allendale customer service at 855-367-6708.

LATE FEES, CHARGES AND PENALTIES

BE ADVISED that P.L. 2021, c. 317 prohibits local governments from charging residential customers interest, fees, or charges for late payment of water charges accruing between March 9, 2020 and March 15, 2022 until after March 15, 2022 at which time interest and penalties may begin to accrue. Late interest, fees or charges may be enforced against arrearages accruing before March 9, 2020 and after March 15, 2022.

BILL ASSISTANCE AND ARREARAGE FORGIVENESS PROGRAMS

The application period for the New Jersey Department of Community Affairs' Low Income Water Assistance Program (LIHWAP) is now open. This federally funded program will provide financial assistance to low-income households to reduce the balances on their residential water bills. LIHWAP will provide benefits directly to water service providers on behalf of residential customers. The assistance can be used, in order of priority, to:

- restore services where services have been terminated and pay reconnection fees and other charges accrued due to a disconnection;
- avoid service disruption for those residential customers who are in danger of disconnection (i.e., received shut off notices or have past due balances) and to help them afford bill payment going forward; and
- support those household customers who are current in their bills but might be in danger of falling behind in the near future.

Priority will also be given to families with elderly or disabled household members and/or with children under the age of five, no matter which category they fall into.

To be eligible for LIHWAP assistance, applicants must be water bill holders who are responsible for paying their water bills directly to the water provider. Also, applicants' total gross household income must be at or below 60% of the state median Income (\$6,439 a month for a family of four). The LIHWAP frequently asked questions webpage, available at <https://njdca-housing.dynamics365portals.us/lihwapfaq> has additional information about maximum income limits and other items.

Participants in the Low-Income Home Energy Assistance Program (LIHEAP) are automatically eligible for LIHWAP assistance so long as they are water bill holders.

Those without computer or internet access can call 1-800-510-3102 to be directed to one of the community action agencies to assist them with starting, completing, and submitting an application online.



BAG UP NJ



Effective May 4, 2022, NJ Law will ban *single-use plastic bags* at all retail stores, food service businesses and grocery stores, as well as *paper bags* at grocery stores at or larger than 2,500 square feet. The law also bans food service businesses from providing *polystyrene foam* food products.

As of November 4, 2021, *plastic straws* will only be available upon a customer's request.

A REUSABLE CARRYOUT BAG IS DEFINED AS A BAG THAT IS:

- Made of polypropylene fabric, PET nonwoven fabric, nylon, cloth, hemp product, or other washable fabric; and
- Has stitched handles, not glued; and
- Is designed and manufactured for multiple reuses; and Is capable of withstanding multiple washes while maintaining usefulness and integrity; and
- Has a minimum of 125 uses.

ALLENDALE POLICE RESPONDING TO COMMUNITY SPEEDING COMPLAINTS



The Police Department continues to receive resident complaints of speeding on numerous County and Municipal roads throughout the Borough. This safety and quality of life issue is taken very seriously by Chief of Police Dillon and all our Police Officers and staff. Municipal speed limit signs have been inventoried by our Department of Public Works and new signs were just added where additional attention to the speed limit was needed. Officers are continuously detailed to directed deterrent speed enforcement based on a list of community complaint roadways. With the approach of warmer sunnier weather, the Police

Department's speed display radar trailers will again be deployed where targeted enforcement initiatives are warranted. Strict radar enforcement follows all radar trailer placements.

The County Engineer has also been requested by Borough Officials to evaluate posted curve warning speeds to determine where lower speeds and increased signage on County roads can be implemented. The County advises all of their roads curve warning speeds will be re-evaluated this year.


