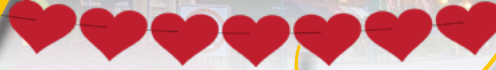

220/230 West Crescent Update

(formerly Black Millwork)



Work has begun in Allendale on 70-unit residential building

ALLENDALE — Construction has started on a 70-unit multifamily residence on the former Black Millwork property.



The Hampshire Companies President James Hanson said the four-story building at 222 West Crescent Ave. is scheduled to be completed in the second quarter of 2024.

The 104,620-square-foot building will feature one- and two-bedroom units, including six affordable units and three units reserved for first responders.

The residence includes a clubroom, storage, a lounge, and a 9,460-squarefoot outdoor courtyard.

The project is a half-mile west of the borough's train station and retail area. The apartment building will sit perpendicular to the west of a municipal gym and multipurpose room to be constructed at 220 W. Crescent Ave. on the front part of the property.

“The borough looks forward to working in tandem with Hampshire as they build their rental units and we build our community center,” Mayor Amy Wilczynski said Tuesday. “They have been a great partner since the beginning. I’m very happy to finally be at the stage where we can build something wonderful and useful for the community.”

The borough purchased the Black Millwork and adjacent Andersen Windows property at 230 W. Crescent Ave., totaling 12.2 acres, for \$14 million in 2017, at least in part to address its affordable housing needs.

Initially, a new Borough Hall was proposed for the Black Millwork site, with its library expanding into the municipal portion of the Borough Hall at 500 W. Crescent Ave. A smaller, three-story, 58-unit apartment building was suggested behind the new municipal building. However, changes in work habits during COVID encouraged officials to rethink moving the municipal offices, and instead to consider its need for a multipurpose room and gym.

The Hampshire Companies acquired the properties in 2021. The Andersen Windows building was converted for storage use, and the apartment complex and gym/multipurpose room were approved for the Black Millwork part of the site.

Hanson said the affordable housing application process would begin closer to the completion of construction.

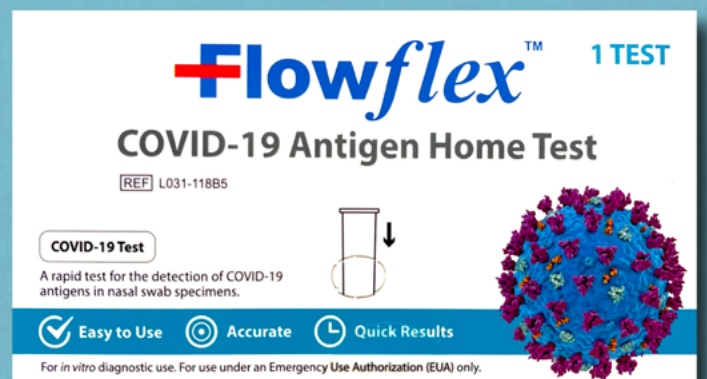



ALLENDALE HISTORY

FLOOD OF 1945

On July 23, 1945, the worst flood in a generation poured over northern New Jersey and southern New York, transforming miles of streets and countryside into rivers of destruction.

The dams at Crestwood Lake and Freeman's Pond gave way to the pressure of swollen streams. The entire business section of Allendale was flooded when water swept down through West Crescent and Myrtle Avenues to cover the borough waist-deep with a sea of turbulent water. Greatest damage to a single area was done to the Erie Railroad, where 200 feet of westbound passenger tracks was washed out, causing long delays in the movement of commuter trains. Trains were detoured over westbound freight tracks during the early stages of repairs.

Mayor George L. Christopher organized rescue and relief forces with the assistance of many volunteer citizens including lifeguards Paul D. O'Connor and Leonard Baum Jr.

Eight members of the Alsdorf family were taken out of their home by boat. A turkey hen with a new brood resisted all attempts at rescue and was lost along with most of the birds raised on the place. The Allendale Celery farm was completely inundated, and the entire crop was lost. Borough marshal Kenneth Booth, responding to an alarm call, stalled his car in the roaring flood sweeping down West Allendale Avenue and had to wade to safety. Recreation Park was completely inundated when Crestwood Lake's retaining wall let go, pouring millions of gallons of water down West Crescent and Allendale Avenues. At its peak the water was waist-deep at the intersection. Brookside Avenue Bridge was completely destroyed along with the iron guard rail and the entire roadbed.

The west-bound track was found suspended in the air with all the ground washed from under it and down the embankment of about 30 feet into the West Crescent Avenue vehicular underpass.

The flood over the railroad tracks was probably caused by the breaking of the dam at the Ramsey Estates, Ramsey, about three miles north of the tracks, which it is also thought to have caused the break in the dam at Crestwood Lake.




There was also considerable damage done in the private homes of the residents, any number of whom had three and four feet of water in their cellars; oil burner motors and washing machine motors were destroyed and gardens washed out with the flood. A few families off Park Avenue were evacuated from their homes in row boats, and there was about 14 inches of water on their first floors.

The restoring and laying of the Erie Railroad west bound track just north of West Crescent Avenue was accomplished after a number of track crews worked the night with the aid of flood lights, relieved by other crews the following day.

The Red Barn is a picnic-style barn that serves as a great location for any event or reunion. This venue is for use by Allendale residents only and is limited to 150 guests.

Fees

- Allendale Families: \$350
- Allendale Businesses: \$1,000
- Allendale Family Sponsorship: \$1,000
- Security Deposit: \$250 (refundable upon satisfactory condition)

Rent the Red Barn

1. Check availability on the calendar to the right.
2. Fill out the online application ([Click Here](#))
 - Follow the instructions on the application. Events will require a copy of the homeowner's Insurance Declaration page. Additional insurance may be required. [Click Here](#) for more details. All paperwork and insurance must be submitted within ten (10) days of the event.
 - Your date **WILL NOT** be reserved until all required documents have been submitted.
3. Refundable Security Deposit of \$250 will be given when picking up the key to the Red Barn at Borough Hall the day before the event. A "Clean Up Check List" will be given with the key. When returning the key please return the completed and signed "Clean Up Check List". Once the inspection of the Red Barn is reviewed after the event, the security deposit will be refunded.

Red Barn Policies

- **Facilities** - The Red Barn features a "Prep Area" including a refrigerator, sink, and preparation tables. All facilities are "as-is"
- **Garbage** - It is your responsibility to put filled trash bags in the dumpster, and set up a new trash bag, which is provided at the bottom of the garbage bin. Garbage bags are supplied in the Prep Area.
- **Tables** - Tables are not to be moved. If they are moved around you are required to place them back in their original location.
- **Attractions** - Bounce Houses and Mechanical Bulls are NOT Permitted.
- **Food Trucks** - There is a 3-truck maximum. A fire inspection is required. Auto Liability for \$1MM will have to be provided. If selling food to the public, a health inspection is required. Please fill out the applications below if you are having a food truck.
Special Events / Fire Permit
- **Larger Events** - Events larger than 150 will need approval of the Mayor & Council's Facility Committee.
- **Nonresidents** - If you are not a resident of Allendale and wish to use the Red Barn, you will need to have a sponsor who is a resident of Allendale and pay the related fee.

GARBAGE & RECYCLING REMINDERS

- All items should be put out *starting at 6pm the night before* the scheduled collection.
- Building materials and wood pallets *are not collected* by our garbage contractor. You must make your own arrangements to dispose of them.
- You must schedule a one-time, courtesy move-out pickup with info@AllendaleNJ.gov at **least 4 WEEKS in advance**. No metal, electronics, or recyclable materials collected.
- Remember to make sure that the lids are securely on top of your cans, especially garbage. This will help keep wildlife at bay.
- Collection containers can be no larger than 30 gallons.
- Bulk Trash must be placed on the curb and **not placed** in the road.
- Food containers being recycled need to be rinsed and cleaned before you dispose.
- Soiled pizza boxes are garbage and **NOT** recyclable.

GARBAGE

- Household kitchen, office and bathroom trash
- Styrofoam

BULKY TRASH

- Furniture
- Carpeting
- Non-metal items
- Windows/mirrors/pane glass must be taped with an "X"

METAL

- Anything that is least 75% metal
- Artificial Holiday Trees



RECYCLING

Container One:

- Newspapers and inserts
- Junk mail, envelopes, office, notebook, construction paper
- Smooth and corrugated cardboard
- Glossy magazines and catalogs
- Soft covered books and telephone books
- Non-metallic wrapping paper and greeting cards
- Shredded paper
- Brown grocery bags

Container Two:

- Food and beverage containers
- Plastic containers with a recycling code 1, 2, 5, 7
- Aluminum cans, foil
- Aseptic packaging (ex: soup, milk containers)
- Metal cans and empty aerosol cans
- Green, clear and brown glass bottles and jars
