### **ORDINANCE 22-02**

# AN ORDINANCE GRANTING CONSENT AND PERMISSION TO SUEZ WATER - NEW JERSEY, INC. TO FURNISH WATER TEATMENT, STORAGE AND CONVEYANCE SERVICE IN THE BOROUGH OF ALLENDALE, NEW JERSEY

WHEREAS, the Borough of Allendale, County of Bergen and State of New Jersey (the "Borough"), hereby grants consent and permission to Suez Water New Jersey, Inc. ("Suez"), a New Jersey Corporation to furnish potable water service within the Borough; and

WHEREAS, Suez is in the process of acquiring the water system (the "System") currently owned and operated by the Borough, which has been approved by the voters of the Borough on November 2, 2021, pursuant to N.J.S.A. 40:62-5; and

WHEREAS, the Borough is desirous of having Suez acquire the Systems; and

WHEREAS, Suez is a regulated public utility corporation of the State of New Jersey presently seeking the municipal consent of the Borough to permit Suez to provide water treatment, storage and conveyance service through the System; and

WHEREAS, Suez has requested the consent of the Borough as required by N.J.S.A. 48:19-17 and 48:19-20, as amended, to lay its pipes beneath and restore such public roads, streets and places as it may deem necessary for its corporate purposes, free from all charges to be made for said privilege (except that fees for road opening permits shall be paid), provided that all said pipes installed after the date of this ordinance shall be laid at least three feet (3') below the surface and shall not in any way unnecessarily obstruct or interfere with the public travel or cause or permit other than temporary damage to public or private property; and

WHEREAS, it is deemed to be in the best interests of the citizens of the Borough to provide this consent; and

**WHEREAS**, notice of this Ordinance was published in accordance with the requirements of N.J.S.A. 48:3-13 and N.J.S.A. 48:3-14; and

WHEREAS, the Mayor and Council of the Borough have concluded that granting of said consent shall enhance the health, safety and welfare of the citizens of the Borough.

### NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE BOROUGH AS FOLLOWS:

- Section 1. That exclusive and perpetual consent and permission to furnish water conveyance to the Borough and all residents, businesses and government buildings therein is hereby given and granted to Suez, its successors and assigns for the maximum duration permitted by law, subject to the permission by the Board of Public Utilities of the State of New Jersey.
- Section 2. That exclusive consent and permission is given to Suez, its successors and assigns, under the provisions of N.J.S.A. 48:19-17 and N.J.S.A. 48:19-20, as amended, without

charge therefore, (except fees for road opening permits which shall be paid) as the same may be required in order to permit Suez to own and operate the System, add to, extend, replace, operate and maintain said System in the public property described herein in order to provide said wastewater conveyance service. This shall include permission to lay pipes beneath the public roads, streets, public property and public places.

- Section 3. That a certified copy of this Ordinance, upon final passage, shall be sent to Suez, the New Jersey Department of Environmental Protection and the Board of Public Utilities of the State of New Jersey.
- Section 4. That the consent granted herein shall be subject to Suez complying with all applicable laws of the Borough and/or the State of New Jersey including, but not limited to, any and all applicable statutes and administrative agency rules and/or regulations and contingent upon the Borough and Suez executing the Agreement of Sale Between the Borough of Allendale and Suez Water New Jersey, Inc, as the same may be amended from time to time.
- Section 5. The Mayor and the Clerk of the Borough are authorized to execute the documents and agreements necessary to effectuate this municipal consent.
- Section 6. Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.
- Section 7. All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**BE IT FURTHER ORDAINED**, that if any portion of this Ordinance shall be declared invalid as a matter of law, such declaration shall not affect the remainder of said Ordinance; and

**BE IT FURTHER ORDAINED**, that this Ordinance shall take effect upon passage and publication.

### BOROUGH OF ALLENDALE ORDINANCE 22-03

### CALENDAR YEAR 2022 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% or the cost of living adjustment, whichever is less, unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS,** the cost of living adjustment for calendar year 2022 budget is calculated at 2.5% pursuant to N.J.S.A. 40A:4-45.2; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Mayor and Council of the Borough of Allendale in the County of Bergen finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Mayor and Council hereby determines that a 1.0% increase in the budget for said year, amounting to \$98,166 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Mayor and Council of the Borough of Allendale in the County of Bergen, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Borough of Allendale shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by up to 3.5%, amounting to \$343,580, and that the CY 2022 municipal budget for the Borough of Allendale be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

### **ORDINANCE 22-04**

# AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 128-8 OF THE CODE OF THE BOROUGH OF ALLENDALE ENTITLED "ADDITIONAL REQUIRED INSPECTIONS AND FEES"

**BE IT ORDAINED** by the Governing Body of the Borough of Allendale, County of Bergen, State of New Jersey that Chapter 128-8 of the Code of the Borough of Allendale, entitled "Additional Required Inspections and Fees", be and hereby is amended, supplemented and revised in its entirety to read as follows:

### § 128-8 Additional required inspections and fees.

- A. In addition to the inspections and fees required pursuant to the Act and the regulations of the Department of Community Affairs, the following inspections and fees shall be required:
  - (1) All industrial and commercial buildings and structures within the boundaries of the Borough of Allendale not covered under the Uniform Fire Safety Act.
  - (2) Eating and/or drinking establishments within a maximum permitted occupancy of less than 50 in which no alcoholic beverages are served.
  - (3) Residential/Multi-Family/Multi-Use (any structure containing three or more dwelling units or structures with dwelling units, attached to commercial businesses).
- B. Each additional inspection herein directed shall require a registration fee, paid annually to the local enforcing agency. The annual registration fee shall be billed annually in accordance with the procedure established by the Administrator's office.
- C. A permit may be required either annually or temporarily as defined by New Jersey State Uniform Fire Safety Act or attached fee schedule.
- D. The following fees shall be required for each building use within the Borough of Allendale. All fees shall be invoiced annually. New businesses will be invoiced upon receipt of registration.
  - 1. Business Registration Fees (any building, structure or premises or part there of used for business)
    - (a) One square foot to 400 square feet: \$ 50.00
    - (b) 401 square feet to 2000 square feet: \$ 75.00
    - (c) 2001 square feet to 5000 square feet: \$ 125.00

- (d) 5001 square feet to 10,000 square feet: \$ 175.00
- (e) 10,001 square feet to 15,000 square feet: \$ 225.00
- (f) 15,001 square feet to 20,000 square feet: \$ 275.00
- (g) 20,001 square feet to 25,000 square feet: \$ 325.00
- (h) 25,001 square feet to 37,500 square feet: \$ 375.00
- (I) Over 37,500 square feet \$ 10.00 per square foot
- 2. Owner Non-occupied Commercial building common areas: \$75.00 flat fee
- 3. Building Owners will be invoiced a fee for any commercial space vacant for more than six months annually.
  - (a) One square foot to 5,000 square feet: \$ 50.00
  - (b) 5,001 square feet to 35,000 square feet: \$ 100.00
  - (c) Over 35,000 square feet: \$ 200.00
- 4. Residential/Multifamily/Multi-use (any structure containing three or more Dwelling units or structures with dwelling units connected to businesses.)
  - (a) Any building with 3 or less residential units: \$ 50.00
  - (b) Any building with 3 or more residential units: \$ 50.00 plus \$ 10.00 per each additional unit over three.
  - (c) Non-Owner occupied one- and two-family dwellings: \$50.00
  - (In Multi-use buildings this fee will be in addition to any business fees)
- 5. Annual fee for each religious organization building: \$50.00
- 6. Permit fees established by type group as defined by the New Jersey State Uniform Fire Code N.J.A.C. 5:70-2.9, shall be as follows:
  - (a) Type 1: \$54.00
  - (b) Type 2: \$214.00
  - (c) Type 3: \$427.00
