Councilwoman Homan - Water, Sewer and Public Utilities

Councilwoman Homan reported that the committee continues to be busy, reminding everyone that selling the system is only one option for the future of Allendale Water with Suez's \$18,000,000 bid offer to purchase the system being the highest. She encouraged residents to get informed by contacting her and/or viewing the five virtual water presentations on the website, as the sale will need to be approved by the voters as a referendum question at November's General Election. The next steps will be to incorporate the bid into a purchase/sale agreement for presentation of an ordinance to the Governing Body on July 8th. Another virtual meeting will be held in July and inperson meetings will be held at later times. She thanked Ron Kistner and Layne Simon for coordinating the sewer system maintenance with NBCUA. COVID prevented the annual clean out of a 1/3 of the lines in 2020 so those are currently being done. 2021's list will be done in the Fall. The committee is also reviewing municipal sewer interconnect agreements. Regarding Allendale Senior Housing, lease agreements with the Borough are being reviewed to determine if their annual payments of approximately \$16,000 can instead be used towards much-needed repairs and upkeep of these low and moderate income units.

Mayor Bernstein expressed his and the Governing Body's admiration and appreciation for all of Councilwoman Homan's efforts.

Councilwoman Homan praised John Gil for his assistance with posting the virtual water presentations on the website.

Mayor's Report:

Mayor Bernstein's report was provided during the Work Session.

Staff Report:

Raymond Wiss, Borough Attorney, shared that it has been a relatively quiet two weeks, but that he will be reviewing documents provided to him by Councilwoman Homan.
