WHEREAS, the Borough of Allendale (“Borough”) requires janitorial services for Borough facilities for the period of January 1, 2026 through December 31, 2026; and

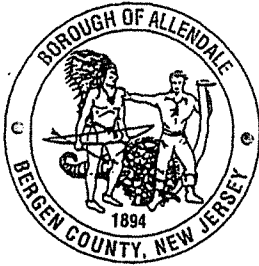
