LAND USE BOARD OF THE BOROUGH OF ALLENDALE RESOLUTION APPROVING THE 2025 HAZARD VULNERABILITY ASSESSEMENT AND AMENDED LAND USE ELEMENT OF THE BOROUGH OF ALLENDALE MASTER PLAN
