Requests should include company name, address, phone number, email and contact person.

Each proposal must be submitted on forms provided by the Borough of Allendale and placed in a sealed envelope bearing the name of the bidder, and clearly marked on the outside of the envelope, "2026 CRESTWOOD LAKE CONCESSION RFP" or they will not be considered.

Questions or requests for explanations may only be submitted by contractors, and not subcontractors. No questions will be answered by phone or any method other than by email set forth above. The subject on all such emails must read, "Crestwood Lake Concession – Bidding RFI." In the body of any such email, each question must be numbered categorized according to professional discipline and must, if needed, refer back to specific items in the specification.

Bidders must enclose with their bid a certified check, cashier's check or bid bond for ten (10%) percent of the amount of their bid. All bidders shall provide a statement which shall

percent (10%) or more of its stock of any class, or of all individual partners in a partnership who own ten percent (10%) of greater interest therein. This information is required pursuant to Chapter 33, Public Law 1997, and cannot be waived or cured after the receipt of bids. Failure to comply will result in the REJECTION of the bid proposal.
