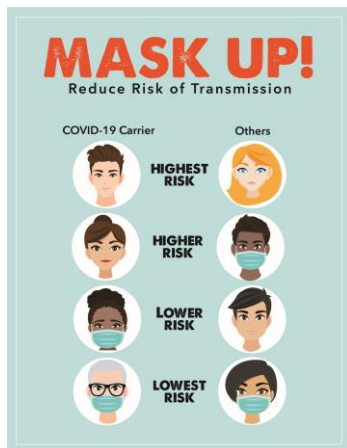

### **O&R/Rockland Electric is reimbursing for Food & Prescription Drug Spoilage during Tropical Storm Isaias**

O & R Residential customers impacted by Tropical Storm Isaias may receive reimbursement for up to \$235, or up to \$540 with receipts if power was lost for more than 48 consecutive hours. Please fill out the claims form which can be found at [www.oru.com](http://www.oru.com) to cover spoiled food, medication or perishable commercial merchandise. Business owners are eligible for food spoilage reimbursements up to \$10,700 with receipts. You may choose to file a claim with your insurance company to reimburse you for your loss (less your deductible). Your insurer may then choose to present a claim to us to recover compensation paid to you. Please note, if you decide to go through your own insurance carrier and are reimbursed by your carrier, you cannot also seek reimbursement from O&R/Rockland Electric.

## REOPENED! - Bergen County CARES Small Business Grant

## NJHMFA'S Small Landlord Emergency Grant Program

Governor Murphy announced the Small Landlord Emergency Grant (SLEG) Program, which reimburses small residential rental property owners for lost rent revenue due to COVID-19 between April and July 2020. By passing the benefit on to their tenants and forgiving outstanding back rent and late fees, landlords will not only receive necessary funds to stay afloat, but will also continue to provide stable housing in what has become an unstable time.
