### **FALSE ALARM BOROUGH ORDINANCE 82-7**

The ordinance states that the residents and businesses are allowed up to three false alarm per calendar year. The 4" alarm will carry a \$20 fine, \$35 for the 1<sup>st</sup> and \$50 for each subsequent alarm.
