**AUTHORIZE SECOND EXTENSION AGREEMENT WITH
165 W. CRESCENT AVE, LLC**

Crescent Ave, LLC (the “Developer”) entered into an agreement (the “Agreement”) regarding the proposed development by the Developer of certain property (the “Property”) more particularly described in the Agreement; and

WHEREAS, more than two (2) years have elapsed since the Agreement was entered into by the Borough and the Developer; and

WHEREAS, the Borough and the Developer extended the term of the Agreement by entering into an Extension Agreement on May 8, 2018; and

WHEREAS, the Borough and the Developer wish to further extend the term of the Agreement by entering into this Second Extension Agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body that it does hereby consent to the foregoing Second Extension Agreement and the Mayor is hereby authorized to execute the form of the Second Extension Agreement attached hereto, the terms of which are incorporated by reference herein.

SECOND EXTENSION AGREEMENT

WHEREAS, in or about December 2015, the Borough of Allendale (“Borough”) and 165 W. Crescent Ave, LLC (the “Developer”) entered into an agreement (the “Agreement”) regarding the proposed development by the Developer of certain property (the “Property”) more particularly described in the Agreement; and

WHEREAS, more than two (2) years elapsed following the date on which the Agreement was entered into between the Borough and the Developer; and

WHEREAS, the Borough and the Developer extended the term of the Agreement by entering into an Extension Agreement on May 8, 2018; and

WHEREAS, the Borough and the Developer wish to further extend the term of the Agreement by entering into this Second Extension Agreement;

NOW, THEREFORE, IT IS ON THIS ____ day of August 2018 agreed to between the Borough and the Developer as follows:


1. Other than as modified by this Second Extension Agreement, all terms of the Agreement shall remain in full force and effect.
2. The Developer shall complete all work contemplated by the Agreement on or before August 15, 2019.
3. Incident to completion of the work set forth in the Agreement, the Developer shall obtain, on or before commencement of any further work contemplated by the Agreement, but no later than August 15, 2018, a Certificate of Liability Insurance naming the Borough as an additional insured. The scope of insurance coverage shall be the same as that set forth in the Certificate of Liability Insurance issued to MMC Construction LLC on July 31, 2017, and shall expire no earlier than August 15, 2019.
