WHEREAS, on July 23, 2020, the Borough of Allendale (the "Borough") adopted Resolution 20-183, awarding the contract (the "Contract") for the 230 West Crescent Avenue Soil Remediation Project (the "Project") to The Ambient Group, LLC ("Ambient") in the amount of Two Hundred Ninety-Eight Thousand Dollars and No Cents (\$298,000.00); and

WHEREAS, as a result of its performance of the work specified in the Contract, Ambient has submitted a Change Order Request ("COR #1") to the Borough for additional soil remediation work necessitated to complete the Project; and

WHEREAS, such additional work (the "Work") was not reasonably foreseen at the time the Contract was awarded to Ambient, and immediate authorization to permit the Work to be performed is required; and

WHEREAS, the Work directly affects the Public's health, safety and welfare, requiring the immediate performance of the same; and

WHEREAS, COR #1 is in the amount of One Hundred Forty-Seven Thousand Thirty Dollars and No Cents (\$147,030.00), which amount exceeds the twenty percent limitation set forth in N.J.A.C. 5:30-11.3; and

WHEREAS, in accordance with <u>N.J.A.C.</u> 5:30-11.3, the Borough must follow the procedures set forth in <u>N.J.A.C.</u> 5:30-11.9 to complete the Work on an emergency basis without public advertising for bids and bidding thereon; and

WHEREAS, in accordance with <u>N.J.A.C.</u> 5:30-11.9, Ambient has submitted COR #1 in the amount of One Hundred Forty-Seven Thousand Thirty Dollars and No Cents (\$147,030.00), and the Borough has received a certification from the Borough Engineer setting forth why the Work is required; why it could not have been foreseen; and why COR #1 is in the best interest of
