### **APPROVAL OF MINUTES:**

## SECRETARY/REGISTRAR'S REPORT

Adult Health Clinic – No clinic was held. Child Health Clinic – No children attended the Well Baby Clinic. Vital Statistics -2 Deaths 4 Births 1 Marriage Receipts - \$56.00 in Marriage Licenses, \$200.00 in Retail Food, \$70.00 in Certified Copies, \$100.00 in Miscellaneous, totalling \$426.00.

#### **HEALTH OFFICER/SANITARY REPORTS**

-Nirvana was conditional. They had improper food temperatures and were not sanitizing properly in their kitchen. They had no chlorine in their sanitizer bucket.

-Both Crestwood Lake and The Whitney were inspected and opened Memorial Day weekend.

## **OLD/NEW BUSINESS**

-Live Well Pediatrics called today to report a case of mumps in Allendale. I forwarded this information to the Bergen County Department of Health Services, Nursing, for follow up.

-An Allendale resident called to complain about the deer population and asked what we are doing about it. I mentioned to her that it is a regional issue and one town alone cannot make a dent in the problem. I then proceeded to scan our 2015 Board of Health meeting wherein Carol Tyler from Tyco and Mayor Elizabeth White came to discuss the situation. I forward this to her as same was very informative.

### **PRESIDENT'S REPORT**

The State Health Department issued a webinar on measles. One thing that stood out was that they talked about Ocean County and did not mention cases in Bergen County. The recommendation was that if you are concerned to get reimmunized, with no risk, or do the Titer testing. There were less cases of Measles in 2019 than in 2018 with twelve cases in Ocean County alone.
