WHEREAS, the Bergen County Open Space, Recreation, Floodplain Protection, Farmland & Historic Preservation Trust Fund (the "County Trust Fund"), provides matching grants to municipal governments for assistance in the development or redevelopment of municipal recreation facilities; and,

WHEREAS, the Borough of Allendale (the "Borough") had received a 2018 Trust Fund matching grant award of \$\\$ which was approved via County of Bergen Board of Chosen Freeholders Resolution No. 195-19, dated March 6, 2019, for its "Crestwood Park Trail Circuit" project (Project Contract No. 1900036); and,

WHEREAS, Crestwood Park Trail Circuit project was to include restoring, enhancing and completing a cross country trail circuit at Crestwood Park, located at 300 W. Crescent Avenue, Block 1003, Lot 6; and

WHEREAS, the Borough of Allendale desires to transfer its 2018 Trust Fund Municipal Program grant award to the Crestwood Park Playground Area Improvements project; and,

WHEREAS, the governing body has reviewed the County Trust Fund Program Statement, and the Trust Fund Municipal Program Park Improvement application and instructions and desires to make such a request for use of its grant and provide application information and furnish such documents as may be required; and,

WHEREAS, as part of such request, the governing body received public comments on the proposed transfer and use of its 2018 Trust Fund Municipal program grant award on March 28, 2019; and,

WHEREAS, the County of Bergen shall determine whether the proposed request and use of the 2018 Trust Fund grant award are complete and in conformance with the scope and intent of the County Trust Fund; and,

WHEREAS, the Borough is willing to use the County Trust Fund grant in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the County of Bergen for the approved project and ensure its completion on or about the project contract expiration date of March 6, 2021.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council:

WHEREAS, Borough Council desires that the current contract property owner, Hampshire Venture Partners, LLC, a New Jersey based company, or a successor or related entity, be the designated redeveloper to perform all project work in accordance with the objectives of the aforesaid redevelopment plan as may be modified to incorporate the appropriate land use and subject to Allendale Planning Board Project review; and

WHEREAS, the Borough Council finds that it is in the best interest of the public to implement the aforesaid redevelopment project, with the contract property owner, and consistent with the redevelopment plan as may be amended.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Allendale, Bergen County, New Jersey, pursuant to the provisions of N.J.S.A. 40A:12A-1 et seq., that Hampshire Venture Partners, LLC, or a successor or related entity organized for the purposes of carrying out the aforesaid redevelopment project, is hereby designated as the redeveloper of the property situated at Block 1005, Lots 3, 20 and 11 as may be necessary to carry out the redevelopment project, upon the premises hereinbefore described, and subject to any required amendments or modifications of the redevelopment plan that may be required;

BE IT FURTHER RESOLVED, that the above preamble (WHEREAS clauses) is made a part of this resolution as though it is a material and actionable part of this resolution;

BE IT FURTHER RESOLVED, pursuant to N.J.S.A. 40A:12A-8, the Mayor is hereby authorized to execute on behalf of the Borough of Allendale a Redevelopment Agreement, consistent with the adopted Redevelopment Plan (ordinance as may be amended), between the Borough of Allendale and the herein designated redeveloper, Hampshire Venture Partners, LLC, or a successor or related entity, so as to carry out the terms and conditions of the redevelopment project, as may be amended or modified; a copy of said agreement shall be placed on file in the office of the Borough Clerk upon execution thereof; and

BE IT FURTHER RESOLVED, that the Borough Mayor, Attorney and Redevelopment Consultant are hereby authorized to enforce and carry out the terms and conditions of the Redevelopment Agreement authorized herein.

Whereas, the Borough of Allendale solicited requests for quotes on Friday, March 15, 2019 with a deadline to respond by Tuesday, March 26, 2019 at 12 noon; and

Whereas, the Borough of Allendale received three responses from Harvest Lawn Care, TruGreen Commercial and Savalawn; and

Whereas, TruGreen Commercial was the lowest responsive bidder; and

Whereas, the Chief Financial Officer has attached hereto a certification that adequate funds have been or will be duly budgeted and appropriated to pay for the contract.

Now, Therefore, Be It Resolved by the Mayor and Council of the Borough of Allendale, County of Bergen, State of New Jersey, that an Agreement is hereby authorized for landscaping services for the 2019 Turf Program with TruGreen Commercial, 118 Route 17 North, Upper Saddle River, New Jersey 07458 in the amount of \$12,263.00; and

Be It Further Resolved that the Mayor, Borough Clerk and Borough Attorney are hereby authorized to take such action as may be necessary to implement this Resolution, including the execution of an Agreement with TruGreen Commercial for the above services.

Council Committee Reports and Comments

Councilman Strauch – Public Safety

Councilman Strauch announced that the next Public Safety Committee meeting is scheduled on April 2^{nd} .

Councilman O'Toole - Public Works

Councilman O'Toole reported that there are currently only eight full-time employees in the DPW and commented that they are working hard to prepare the Borough for spring. Dan Richards, Crew Chief, is conducting final inspections on the winter equipment as well as preparing the lawn equipment. Street sweeping took place this week under the recently awarded contract with TSS Facility Services, Inc. Spring cleanup is scheduled next week for a number of Borough properties. Landscaping services that were awarded this evening through TruGreen are scheduled to take place during the week of April 14th when the schools are closed.

Councilwoman Wilczynski - Facilities, Parks and Recreation

Councilwoman Wilczynski advised that, as the Borough is still in the due diligence period with respect to the sale of 220 and 230 West Crescent Avenue, there are reports and paperwork that are in the process of being reviewed and completed. There was a meeting with the Vision Committee to provide them with a brief update. The next Vision Committee meeting is scheduled on April 2nd.

With respect to Crestwood Lake, the lake is being prepared for the upcoming season with the walls being painted and bottom being scraped. It is anticipated that the lake will begin to be filled on April 15th. Councilwoman Wilczynski commented that the fields are looking great. The turf blankets were removed and the grass underneath is nice and green. Opening day is scheduled on April 1st. Field 2 had a nice overhaul as new dugouts were installed and sprinklers and electricity will be installed next. The floors as the Red Barn will be painted. The band shell has been ordered and delivery is awaited. Two newsletters will be sent to residents in the near future. Councilwoman Wilczynski commented that they both will be full of useful information. She noted that the Borough is celebrating its 125th anniversary and a lot of events will be planned in honor of this milestone. The mural project in the downtown is underway.

Councilman Sasso - Administration, Finance and Human Resources

Councilman Sasso commented that his committee report was covered by Resolution #19-103 and noted that the Administration, Finance and Human Resources Committee works very hard on preparing the budget. He expressed his opinion that the committee has done a phenomenal job and stated that he is humbled to be a part of this committee.

Councilwoman Homan – Water, Sewer and Public Utilities

Councilwoman Homan advised that the Water, Sewer and Public Utilities Committee met on March 19th. The capital budget was discussed which will include funds to power wash the Fairhaven Tank and complete valve repairs. She explained that the valves will be checked in a systematic fashion as is required by the Water Accountability Act. She reminded residents to continue to check their water bill to ensure that it is not estimated. She advised that, as streets are paved each year, the water lines are checked to see if any repairs are needed. Mike Vreeland is coordinating with Suez and Layne Simon of the DPW on the Asset Management Plan. The first version of this plan is expected to be completed in mid-April. The portion of the Borough Code pertaining to water was also reviewed to see what changes, if any, were necessary.

As Councilman O'Connell was absent, Mayor Bernstein noted that the Land Use and Construction Code Committee is scheduled to meet on April 8th.

Mayor's Report:

Mayor Bernstein reported that the Vision Committee met on March 18th and commented that it was a very good meeting. He advised that this committee is scheduled to meet again on April 2nd.

Mayor Bernstein and Councilwoman Wilczynski met with the Holiday Observers to discuss the Centennial Celebration which is scheduled on September 7th.

Compost permit sales began this past Monday and the application is available to submit online through GovPilot.

Staff Reports:

Ray Wiss, Municipal Attorney, reported that he has spent a lot of time on 220 and 230 West Crescent Avenue. He explained that one of the components involved is the affordable housing component as it is the final element in receiving unconditional approval from the court. Time was also spent on agenda items, contract matters and personnel matters. Borough Attorney Wiss also discussed with Chief Scherb positive initiatives being undertaken by the Police Department which included the SLEO Class III discussed earlier this evening.

Anne Dodd, Municipal Clerk, advised that 28 OPRA requests have been received to date this month and 93 total requests have been received to date this year. Her office has been busy issuing compost permits. She noted that she is in the process of updating the Borough's roster of local government officers who are required to file Financial Disclosure Statements. The deadline to complete this roster update is tomorrow and she will be notifying those who are required to file once notification is received from the Local Finance Board that filing can begin.

Alissa Mayer, CFO, stated that homestead credits have been applied to accounts and the new revised 2^{nd} quarter payment will be sent out tomorrow. She noted that only half was received at this point and the other half is expected in November.

Public Comment on any issue:

Tyler Yaccarino, 108 Hillside Avenue, thanked the governing body, on behalf of the Chamber of Commerce, for approving both Resolution #19-109 and #19-110.

Walter Widmer, 38 Hamilton, inquired about the new construction that is being built across the street from Savini's Restaurant.

Councilwoman Wilczynski explained that there are 5 special needs bedrooms that are being built at this location and will be credited towards the Borough's affordable housing obligation.

Mr. Widmer advised that he received information on the "Hamilton Street Neighbors" and inquired if the governing body had any information on this organization. He was informed that it is a social media site and is not affiliated with the Borough.

Ryan Heath, 43 Hamilton, advised that the fence on Hamilton near the 220 and 230 site is in need of replacement.

Councilwoman Wilczynski responded that this fence should be replaced as part of this project.

Adjournment:

There being no further business to come before the Mayor and Council, on a motion by Councilman Sasso, second by Councilman Strauch, and unanimously carried, to adjourn this meeting. The meeting was adjourned at 8:47p.m.
