Self-Examination of 2019 Municipal Budget

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Borough of Allendale has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2019 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the Borough of Allendale that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:

- a. Payment of interest and debt redemption charges
- b. Deferred charges and statutory expenditures
- c. Cash deficit of preceding year
- d. Reserve for uncollected taxes
- e. Other reserves and non-disbursement items
- f. Any inclusions of amounts required for school purposes.

2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).

3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.

4. That pursuant to the Local Budget Law:

- a. All estimates of revenue are reasonable, accurate and correctly stated,
- b. Items of appropriation are properly set forth
- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.

5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.

6. That all other applicable statutory requirements have been fulfilled.

Resolution Authorizing Execution of Limited Release with Andersen Logistics and Anderson Windows Regarding 230 West Crescent Avenue, Allendale, New Jersey

WHEREAS, the Borough of Allendale ("Allendale") is the successor Landlord to a Lease Agreement dated October 15, 2009, by which Andersen Distribution, Inc. d/b/a Andersen Logistics ("Andersen Logistics") leased that certain premises located at 230 West Crescent Avenue, Allendale, New Jersey; and

WHEREAS, the October 15, 2009 Lease was previously amended by way of four amendments, dated June 21, 2011, March 22, 2016, May 24, 2017 and January 31, 2019, respectively, (the October 15, 2009 lease as amended being hereinafter referred to as the "Lease"); and

WHEREAS, Andersen Windows, Inc. ("Andersen Windows") by Lease Guaranty signed by it on October 15, 2009 is the guarantor of all of Andersen Distribution's obligations under the Lease (Andersen Logistics and Andersen Windows being collectively referred to hereinafter as "Andersen"); and

WHEREAS, the foregoing Lease has terminated as of April 30, 2019; and

WHEREAS, Allendale has agreed, in exchange for the sum of \$45,000 to be paid by Andersen, to provide Andersen a limited release from certain obligations required of them under the Lease at the time of the termination of the Lease and to enter into a Limited Release agreement memorializing such agreement, the terms of which Limited Release are incorporated herein by reference;

NOW, THEREFORE, BE IT RESOLVED that the Mayor be and hereby is authorized to execute and enter into the Limited Release agreement on behalf of the Borough; and

BE IF FURTHER RESOLVED that the Mayor, Borough Clerk and Borough Attorney are authorized to take any and all appropriate actions to implement the terms of the Limited Release agreement.

BE IT FURTHER RESOLVED that the Mayor, the Borough Clerk and the Borough Attorney are authorized to take all appropriate actions so as to implement this Resolution.

Appointment of Borough Professional

Whereas, there exists in the Borough of Allendale a need for the services of a firm specializing in the investigation, research, planning, preparation and pursuit of programs submitted to various federal, state and county authorities and foundations for obtaining vital financial and other aid for municipal programs; and

Whereas, such services involve professional knowledge and public relations consultants as well as specialized knowledge of available federal, state, county and foundation grant programs and the numerous applications, submissions and actions necessary to obtain and successfully pursue such

programs and involve such qualified services and knowledge that specifications cannot reasonably be formulated and public bidding is not feasible; and

Whereas, it is contemplated that the temporary and permanent budgets will contain the necessary appropriations estimated to be reasonably required for each such professional service; and,

Whereas, the professional named herein will be required to execute a contract for the services to be rendered which shall set forth the compensation for such services therein; and,

Whereas, a Certification of availability of funds has been received from the Chief Financial Officer or that such funds will be encumbered by Purchase Order on an as-needed basis pursuant to the provisions of NJAC 5:30-5.4 et seq; and,

Whereas, in any instance where it is anticipated that the expenditure for each such professional service will exceed the sum of \$17,500 for said calendar year, the named professionals have completed, submitted and filed a Business Entity Certification Disclosure which certifies that the above named persons and/or entities have not made any reportable contributions to any political or candidate committee including (Republicans for Responsible Government, Allendale Republican Club, Allendale Democratic Club, Candidates for Allendale Municipal Government, Bergen County Democratic Organization, Bergen County Republican Organization) in the previous one (1) year, and that the contract will prohibit the above named professionals/business entities from making any reportable contributions through the term of the contract.

Now, Therefore, Be It Resolved by the Mayor and Council of the Borough of Allendale that the following appointment be and is hereby made for the year:

Be It Further Resolved that the contract is being awarded as a non-fair and open contract, pursuant to the provisions of NJSA 19:44A-20.5;

Grant Writer Bruno Associates, Inc.

Council Committee Reports and Comments

Councilman Strauch – Public Safety

Councilman Strauch announced that the Public Safety Committee is scheduled to meet on May 21st at 5:30 p.m. The Allendale Police Department has made two arrests in connection with mailbox thefts. Councilman Strauch reminded residents to secure their homes and vehicles. Sgt. Bill Kroepke, Firearms Instructor, had all of the officers requalified for the new rifles that will be deployed as part of the accreditation requirements. Thirty-one applications have been received for the Junior Police Academy.

Councilman Strauch advised that he attended an Allendale Volunteer Goose Patrol Committee meeting earlier this evening. The four test dates at Crestwood have taken place and 50 families have applied to become members. An outside trainer conducted the evaluations and the results will be emailed. The committee will be working with those dogs who did not pass the evaluation and retesting will take place on June 12th.

Councilman O'Toole – Public Works

Councilman O'Toole reported that the Public Works Committee met last Friday and discussed ongoing personnel matters as well as ongoing work at Crestwood Lake. He advised that the contract award for the 2019 Paving Program through the cooperative was approved earlier this evening and the streets being paved will include DeMecurio Drive, Princeton Road, Cambridge Road and the Allendale Police Department parking lot. Additionally, through the County, Hillside Avenue, Brookside Avenue, and W. Orchard Street will be paved. Four tons of asphalt has been used to address potholes throughout the Borough, several catch basins have been rebuilt, and landscaping of Borough properties is underway. Monthly street sweeping is scheduled to take place next week. Dan Richards, Crew Chief and Borough Mechanic, has been completing preventative maintenance on the salters and plows in order to prolong the life of the equipment. The 2018 tonnage report required by the NJ DEP has been successfully submitted for which Councilman O'Toole expressed appreciation to Michelle Ryan, Deputy Clerk, who was instrumental in having this report completed. The Bergen County Board of Chosen Freeholders approved a resolution authorizing the drainage project on Franklin Turnpike. The Borough will be taking the lead on this project to ensure that it is completed within the Borough's timeframe.

Mayor Bernstein expressed his heartfelt gratitude to Mayor Emeritus White and Mr. Kistner who spent a lot of time to ensure that this project gets completed.

Councilwoman Wilczynski – Facilities, Parks and Recreation

Councilwoman Wilczynski announced that the Borough is celebrating its 125th anniversary this year and Joanne Hart will be giving a presentation this evening entitled "Now and Then," which features historic photos of Allendale. This year also marks the 100th anniversary of the Holiday Observers and this organization will be having an event on September 7th to commemorate this occasion. The downtown mural will be restored and it is anticipated to be revealed in October. The Facilities, Parks and Recreation Committee met this week. Tree removals around the field have been completed. New sprinklers, electricity and dugouts have been installed at Field 2. Councilwoman Wilczynski commented that the lake looks great and the revenues are in great shape. She advised that the newsletter has been delivered and is full of useful information on recycling. Residents are encouraged to continue to recycle despite the challenges in the market and are being asked to stop

using plastic bags and bottles. She announced that "Saturdays with the Mayor and Council" will be starting, noting that it will be an informal forum for questions to be answered and issues to be addressed. With respect to grants, she remarked that there are a few upcoming open space grants that are being prepared and work continues on the Downtown Streetscape project.

Councilman Sasso – Administration, Finance and Human Resources

Councilman Sasso advised that the Administration, Finance and Human Resources Committee will be meeting on May 15th.

Councilwoman Homan – Water, Sewer and Public Utilities

Councilwoman Homan explained that the Borough has a contract with Suez for the operation and maintenance of its water system. She advised that the testing requirements have increased tremendously in recent years and one of the contaminants that has become subject to mandatory testing in 2019 is PFNA. She provided an explanation of PFNA and advised that Allendale received the results of this testing this week. She then provided the following information from Suez regarding the results of this testing:

- PFNA is the only PFAS compound that has an MCL (Maximum Contaminant level) set by the regulator at 13 ppt. Allendale's Water System remains well below the MCL for PFNA at all entry points to the distribution system. According to the regulation, Allendale meets the water quality standard for PFNA.
- PFOA and PFOS were also detected at the entry points to the distribution system. The results of all sampling performed by SUEZ have been provided to Allendale and all have been well below the Health Advisory Limit set at 70 ppt. The value shown on EWG's Web site was not the result of any analyses performed by SUEZ.
- SUEZ continues to monitor for PFAS compounds, including PFNA, PFOA and PFOS, and will work with the regulator accordingly, for all water quality matters.

She reported that Allendale has conducted meetings in person and on the phone this week with Suez to better understand this new information and will continue address any concerns that may arise in future. Additionally, the committee will be evaluating whether to refurbish or replace Pump #2 at the New Street Station. Should residential meters need to be replaced, Councilwoman Homan asked that residents cooperate with Suez and Layne Simon of the DPW to provide access to their residence. She further requested that residents call the number on their water bill if there is an estimated reading. The next Water, Sewer and Public Utilities meeting is scheduled on May 14th.

Councilman O'Connell – Land Use and Construction Code

Councilman O'Connell reported that the Land Use and Construction Code Committee is scheduled to meet on May 13th. He thanked the Finance Committee, Borough Auditor, CFO and Department Heads for putting together an excellent budget. He advised that the Borough Planner's comments on the portion of the Borough Code pertaining to signs and neon lights have been emailed to the committee. At Councilman Sasso's request, the committee is also investigating what, if any, restrictions can be put into place regarding pop-up stores.

Mayor's Report:

Mayor Bernstein advised that, with respect to 220 and 230 West Crescent Avenue, the committee continues to work diligently on negotiations and ancillary agreements with the prospective purchaser. He noted that the due diligence period is continuing. He attended a crash simulation program at Northern Highlands. He commented that the speaker was excellent and spoke on the perils of driving under the influence of drugs and alcohol as well as driving while distracted. He advised that he participated in the Hemophilia Walk. Autumn Years had its expo at Guardian Angel Church and Mayor Bernstein expressed kudos to Heidi Gross for her work in putting this event together. A complaint was received regarding noise pollution which has been referred to the Land Use and Construction Code Committee for further discussion. Accuscan is coming on Monday to pick up 40 more boxes of Building Department records for scanning. Mayor Bernstein thanked Councilwoman Wilczynski, Jackie McSwiggan, and Heidi Gross for their work on the Borough Newsletter. The Vision Committee is scheduled to meet on May 15th to discuss the anticipated construction of the new Borough Hall.

Mayor Bernstein recognized Tyler Yaccarino, DPW Administrative Assistant and Webmaster, who he commented has been a tremendous asset to the Borough. He advised that Mr. Yaccarino is graduating from Ramapo College and will be leaving his position at the DPW. He expressed congratulations, thanking Mr. Yaccarino for all that he has done and continues to do for Allendale and noted that Mr. Yaccarino will stay on as the Borough Webmaster.

Councilwoman Homan remarked that it has been a pleasure to work with Mr. Yaccarino, expressing that he has always been willing to help anytime he has been asked.

Staff Reports:

Ray Wiss, Municipal Attorney, advised that he has been working with Mr. Kistner on personnel matters. He noted that 220 and 230 West Crescent Avenue is a complicated project with many aspects, one of which is the Borough's affordable housing plan. With respect to COAH, Borough Attorney Wiss advised that the Borough has received conditional compliance and final compliance is anticipated to be received in June. He explained that the ordinance introduced earlier this evening is part of this compliance.

Anne Dodd, Municipal Clerk, reported that 20 OPRA requests have been received since the last Mayor and Council meeting and a total of 152 requests have been received to date this year. Her office will be open until 9 p.m. on May 14th for Late Night Voter Registration as this date is the deadline to register to vote in the Primary Election on June 4th. Polls will be open from 6 a.m. to 8 p.m. one June 4th. She advised that Crestwood Lake photos will also be taken on May 14th.

Alissa Mayer, CFO, announced that May 10th is the deadline for 2nd quarter taxes to be paid without a penalty.

Ron Kistner, Administrative Officer/Director of Operations, advised that he has no report.

Public Comment on any issue:

Kristen Tsarnas, 74 Heights Road, and Kristen Rutter, 24 Cambridge Drive, advised that they represent the Crestwood Cruisers. They expressed concern regarding the limited Crestwood Lake

hours during the month of June as the Crestwood Cruisers are scheduled for practice after school during the week in June.

Councilwoman Wilczynski explained the reasons for the limited hours during June and expressed her belief that Tom Viscardi, Lake Director, has made arrangements for the Crestwood Cruisers. She advised that she would confirm this information with Mr. Viscardi.

Adjournment:

There being no further business to come before the Mayor and Council, on a motion by Councilman Strauch, second by Councilwoman Homan, and unanimously carried, to adjourn this meeting. The meeting was adjourned at 8:41 p.m.
