The meeting was called to order at 8:00p.m. by Mayor Bernstein who reminded the public to mute their phones so as not to distract from the business of the meeting. Mayor Bernstein advised the public that they would have several opportunities at appropriate times throughout this meeting to be heard.

Committee Reports and Comments:

The committee reports of Councilmembers O'Connell, Homan, Sasso and Wilczynski were given during the Work Session.

Councilman O'Toole – Administration, Finance and Human Resources

Councilman O'Toole applauded Mr. Kistner and Ms. Mayer for keeping spending to a minimum. He also thanked Councilman Sasso for arranging for an intern from Northern Highlands in the fall.

Mayor and Council of the Borough of Allendale Regular Session Meeting Minutes July 23, 2020

Councilman Strauch – Public Works

Councilman Strauch mentioned a water issue that he experienced in his house and how his meter helped him detect it. He commended Councilwoman Homan and the water department for their diligent and innovative efforts to deliver quality water to the residents. Councilman Strauch also applauded the teamwork of the entire DPW, acknowledging their work especially at the compost center, downtown dine out nights and keeping the borough in good shape. He expressed his appreciation for the recent e-newsletter and recognized Councilwomen Wilczynski and Homan for spearheading it. He also shared that West Milford reached out to get information as they are hoping to establish their own volunteer goose patrol.

Mayor Bernstein invited Sgt. Terry Lawler of the Allendale Police Department to speak to the public regarding recent concerns of speeding in town. Sgt. Lawler advised that, in response to the concerns, the department is implementing increased radar enforcement in specific areas. He also reminded residents to contact the police desk when there is a concern about speeding in the neighborhood so it can be added to the department's list of monitored streets. They have deployed speed trailers to different streets in town to gather hard data and that a new speed sign has been placed on Brookside Avenue based on the speed reports received. There is also increased patrolling in strategic locations and at specific times based on the data received from the speed surveys.

Mayor Bernstein thanked Sgt Lawler for his report and for the department's vigilant efforts to address the speeding issue in town.

Mark Savastano, 22 Vreeland Place, expressed his concerns about traffic safety and parking in the downtown area. Sgt. Lawler invited Mr. Savastano to reach out to him for follow up by Chief Scherb and the traffic safety officers, Sgt. Griffith and Officer Stettner. Mayor Bernstein asked that he and Councilmen O'Connell and O'Toole, the public safety committee, also be included in the email.

Mayor's Report:

Mayor Bernstein gave the following address to the public:

With rising numbers throughout the state and country, we must all remain committed to stopping the spread of COVID-19 by continuing social distancing practices and wearing masks. Please rest assured that Allendale's OEM team, in cooperation with the County of Bergen and State of New Jersey, has been and will continue to work tirelessly to keep residents safe and informed. Staff Report:

Mr. Wiss, Borough Attorney, shared that it was a busy two weeks working on the 220/230 purchase and sale agreement and other ancillary documents.

Mr. Kistner reported that a squirrel damaged one of the air conditioning compressors at the library and that repairs were being authorized. Additionally, a number of catch basins were in the process of being inspected and repaired boroughwide. The monthly street sweeping is scheduled for tomorrow in time for the weekend's downtown outdoor dining. He also reported that he has been working with Mr. Wiss, Mrs. Mayer and Ms. Ryan to disseminate new COVID-19 regulations to employees. He thanked everyone for their assistance.

Ms. Ryan briefly mentioned the Bergen County board of elections finished counting the ballots and have released the unofficial totals. The certified results are expected at 4PM tomorrow.

Mrs. Mayer reminded everyone that taxes are due August 1st with a grace period until August 10th. Payments can be made online through the borough website, mailed or dropped off in the secure mail slot at Borough Hall.

Public Comment on any issue:

Mark Savastano, 22 Vreeland Place, gave a brief update on the Styrofoam recycling progress. He thanked Councilman Strauch, Councilman O'Connell, and Mr. Frost for their efforts on the committee. He thanked Councilwoman Wilczynski for providing him with an informative article, which led to discovery of more resources. He shared that there is a machine that can be purchased to start a program to produce market valued recycled Styrofoam products. Councilman Sasso inquired as to who would incur the cost of this machine, which is around \$60,000. Councilman O'Connell shared that he had been in contact with Bergen County to see if they have would finance or had grant options available.

Chris Monagle, 244 Schuyler Road, offered to send Mark Savastano information about the Styrofoam collection Upper Saddle River did over the winter. Mr. Monagle should email information to Michelle Ryan for her forwarding to Mr. Savastano.

No other public came forward to comment.
