A Work Session Meeting of the Mayor and Council of the Borough of Allendale was held in the Municipal Building at 500 West Crescent Avenue, Allendale, NJ on October 24, 2019. The meeting was called to order at 7:31 p.m. by Mayor Ari Bernstein who asked that the Municipal Clerk read the open public meetings statement:

Sgt. John Mattiace thanked everyone who assisted in these responses, commenting that the successful outcome would not have been possible without the support of those who were recognized this evening.

### To Be Considered

A. Revisions to Chapter 170 "Noise"

Mayor Bernstein advised that concerns have been raised regarding the hours during which noise resulting from landscaping equipment is permitted to take place. He noted that there is a delineation within the Borough Code between commercial and non-commercial landscaping equipment, with the operation of non-commercial equipment being permitted between the hours of 8 a.m. and 8 p.m. on the weekends. He advised that the Land Use Committee is considering amending the start time on a Sunday to a later time and inquired whether the governing body is in favor of this revision. In addition, Mayor Bernstein noted that other revisions may be necessary as there is reference to a Noise Control Officer as well as equipment that is necessary to gauge the noise level which the Borough does not currently have.

After some discussion, the consensus of the governing body was to investigate making the proposed revisions to Chapter 170 of the Borough Code. It was decided to take this matter back to the Land Use and Public Safety Committees for further review.

### Administration:

A. Agenda Review

Mayor Bernstein reviewed the Regular Session agenda. He provided an overview of the resolutions on the Consent Agenda. With respect to Resolution #19-232, which authorizes an auction of Borough property through GovDeals, Councilman Sasso commended Mr. Kistner who has implemented his suggestion to sell unused equipment and return this money to the taxpayers.
