Thank You Councilman Strauch for your service and dedication to the Borough of Allendale.



It seems like the cold weather is rapidly approaching. As we spend more time together inside our homes, going out in the elements may be necessary. If you choose to venture out during snow or ice, the Allendale Office of Emergency Management would like to remind residents of the following safety tips:

Cold Weather Driving

- Keep a bundle of cold-weather gear in your car, such as extra food and water, warm clothing, a flashlight, a glass scraper, blankets, medications, and more.
- Make certain your tires are properly inflated and have plenty of tread.
- Keep at least half a tank of fuel in your vehicle at all times.
- Never warm up a vehicle in an enclosed area, such as a garage.
- Do not use cruise control when driving on any slippery surface, such as on ice and snow.

Driving in the Snow



Stay home. Only go out if necessary. Even if you can drive well in bad weather, it's better to avoid taking unnecessary risks by venturing out.

Drive slowly. Always adjust your speed down to account for lower traction when driving on snow or ice.

Accelerate and decelerate slowly. Apply the gas slowly to regain traction and avoid skids. Don't try to get moving in a hurry and take time to slow down for a stoplight. Remember: It takes longer to slow down on icy roads.

Increase your following distance to five to six seconds. This increased margin of safety will provide the longer distance needed if you have to stop.

Know your brakes. Whether you have anti-lock brakes or not, keep the heel of your foot on the floor and use the ball of your foot to apply firm, steady pressure on the brake pedal.

Don't stop if you can avoid it. There's a big difference in the amount of inertia it takes to start moving from a full stop versus how much it takes to get moving while still rolling. If you can slow down enough to keep rolling until a traffic light changes, do it.

Don't power up hills. Applying extra gas on snow-covered roads will just make your wheels spin. Try to get a little inertia going before you reach the hill and let that inertia carry you to the top. As you reach the crest of the hill, reduce your speed and proceed downhill slowly.

Don't stop going up a hill. There's nothing worse than trying to get moving up a hill on an icy road. Get some inertia going on a flat roadway before you take on the hill.

2022 CHRISTMAS TREE COLLECTION

The Department of Public Works will be collecting and chipping Christmas Trees. All trees must be free of decorations, tree stands and plastic bags.

- West Side Collection: Weeks of Jan. 3 & Jan. 17
- East Side Collection: Weeks of Jan. 10 & Jan. 24

Decorative wreaths and garland, held together with wires, must go with household garbage.

GARBAGE & RECYCLING REMINDERS

- All items should be put out starting at 6pm the night before the scheduled collection.
- Wood pallets are not collected by our garbage contractor. You must make your own arrangements to dispose of them.
- You must schedule a one-time, courtesy move-out pickup with <u>TatianaMarquis@AllendaleNJ.gov</u> at <u>least 3 WEEKS</u> in advance. No metal, electronics, or recyclable materials collected.
- Remember to make sure that the lids are securely on top of your cans, especially garbage. This will help keep wildlife at bay.
- Collection containers can be no larger than 30 gallons.
- Bulk Trash must be placed on the curb and **not placed** in the road.
- Food containers being recycled need to be rinsed and cleaned before you dispose.
- Soiled pizza boxes are garbage and NOT recyclable.

Did You Know...

...that the Borough recently passed a resolution establishing a voluntary ban on the purchase, sale, and use of anticoagulant rodenticides in Allendale. Anticoagulant rodenticides are used in bait which the rodents ingest causing lethal internal hemorrhaging. Unfortunately, pets and wildlife may also become sick or die from ingesting rodenticides directly or due to secondary exposure after consuming the dead or dying rodents. We encourage businesses and property owners in Allendale to no longer use or sell anticoagulant rodenticides.

... if you need to remove a tree from your property, you will need to apply for a permit with the Borough. <u>Boro Code</u> <u>Permit Link</u>

... that temporary contractor signs are not permitted anywhere in Allendale. Please let your contractor know that they are not permitted to post them . Boro Code

... that no person or persons shall feed, cause to be fed or provide food for any dog, cat, bird, fish or any other animal in any public park, parking area, playground, recreational facilities or public lands within the Borough of Allendale. <u>Boro Code</u> The feeding of deer is also prohibited. <u>Boro Code</u> .. that commercial or industrial power tools and landscaping and yard maintenance equipment, excluding emergency work, can not be operated on a residential property or within 250 feet of a residential property line when operated on commercial or industrial property, between the hours of 6:00 p.m. and 7:00 a.m. on weekdays, or between the hours of 6:00 p.m. and 9:00 a.m. on weekends or federal holidays. <u>Boro Code</u>

... that sidewalk repairs are the resident's responsibility unless damaged by a Borough shade tree. <u>Boro Code</u>

... that drones are prohibited from flying in any airspace below 400 feet within the Borough. Except as otherwise provided in § 118-3, unmanned aircraft are prohibited from flying in any airspace below 400 feet with the Borough in:

(1) The airspace over any residential or commercial zoned area in the Borough;

(2) The airspace over any roads with the Borough; and

(3) The airspace over any government or public buildings, property, or parks with the Borough. <u>Boro Code</u>

... that no vehicle should be parked on residential lawns. Boro Code

... that leaf piles being pick up by landscapers must be placed on the curb and not in the road. <u>Boro Code</u>

... that if you are moving, you must coordinate your complimentary onetime move-out pickup with the Borough Clerk's office. The pickup is to be used as your last pickup of garbage and bulk items and should be scheduled accordingly. Due to scheduling availability, please reach out to Tatiana Marquis one month prior to your closing date. Please call (201) 818-4400 x 218 or email <u>TatianaMarquis@allendalenj.gov</u>. There is a five piece limit of furniture. Please be aware that items that are recyclable, metal, household hazardous waste, and electronics will not be collected. Please refer to the Borough's Garbage & Recycling Guide for appropriate disposal of said items. Please note that no garbage can be left out at the curb after your move-out pickup and should not be left for the new homeowners..

SERVICE SHUTOFF MORATORIUM

BE ADVISED that Executive Order 229 currently prohibits a local government from shutting off water service to a residential customer, or to accounts primarily serving residential customers, due to nonpayment of water charges unless the disconnection is to prevent or ameliorate a risk to public health or safety. **This shutoff moratorium remains in effect until January 1, 2022.**

LATE PAYMENT PENALTY AND LIEN ENFORCEMENT MORATORIUM

BE ADVISED that, **until January 1, 2022**, Executive Order 229 places a moratorium on local governments enforcing late payment charges and penalties on water accounts, or referring a delinquent water payment to tax sale. **On or after January 1, 2022**, charges and penalties may be imposed for delinquent payments, and any payments remaining delinquent may be subject to water service shut-off or referred to a tax lien sale held by the municipal tax collector.

BILL ASSISTANCE AND ARREARAGE FORGIVENESS PROGRAMS

The New Jersey Department of Community Affairs (DCA) is currently developing a Low-Income Household Water Assistance Program (LIHWAP). This program is designed to assist water and sewer customers facing economic hardship due to the COVID-19 pandemic. Further information will be provided once the program goes live.

OPPORTUNITY TO REPAY ARREARAGES IN INSTALLMENTS

BE ADVISED that residents experiencing economic hardship during COVID-19 and who are behind on their water payments may be eligible to enter into an agreement whereby the resident agrees to pay their arrearages in installments over a period of time. WHO IS ELIGIBLE FOR A COVID-19 VACCINE IN NEW JERSEY? Last Updated: 11/04/2021

Everyone 5 years or older is eligible for a COVID-19 vaccine in New Jersey and encouraged to get vaccinated as soon as possible.

- All adults (18 and older) are eligible for the two-dose Pfizer, two-dose Moderna or one-dose Johnson & Johnson vaccines.
- All adolescents ages 12 through 17 are eligible for the two-dose Pfizer vaccine.
- All children ages 5 through 11 are eligible for the pediatric two-dose Pfizer vaccine.
- People who are moderately to severely immune compromised are eligible for a third dose of the Pfizer or Moderna vaccines.
- All adults (18 and older) who received a single dose of the Johnson & Johnson vaccine are eligible for a booster dose, at least two months after their shot.
- Adults 65 and older, long-term care residents, adults with underlying medical conditions, and adults who work or live in high-risk settings who received the two-dose Pfizer or Moderna vaccine are eligible for a booster shot at least six months after their second shot.


