I, and each member of the Council, have expressed unanimous support for this sale. Now, the decision is in your hands. There will also be some in-person events in the borough where you can learn more. The dates for those events are listed in this Newsletter. I encourage everyone to speak to me, Councilwoman Liz Homan, and any Council member with any questions you may have.

2. Vote by Mail.

 - Mailing it in as soon as possible. Your ballot must be postmarked on or before Election Day.

2020 SENIOR FREEZE (PROPERTY TAX REIMBURSEMENT) PROGRAM

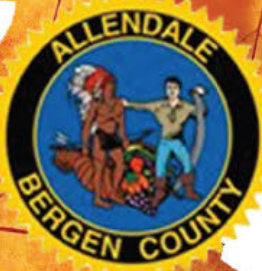
While nobody likes tax increases, Senior Citizens and Disabled Citizens who meet the following qualifications can apply for the NJ Property Tax Reimbursement Senior Freeze Program. This program reimburses the property owner for the increase in taxes calculated from the base tax year. The base tax year is the first year you apply for and are eligible for the program. While the Senior Citizen must still pay their taxes, the net effect is a zero increase once their reimbursement check is received. This is a very valuable program. The deadline is November 1, 2021. So, if you are a Senior or Disabled Citizen not already participating in the program, please call the State at 800-882-6597 for further information.

- You must have been age 65 or older as of December 31, 2019 OR receiving Federal Social Security disability benefits on or before December 31, 2019 and December 31, 2020; and
- You must have lived in NJ continuously since December 31, 2009 as either a homeowner or a renter; and
- You must have owned and lived in your current home on or before December 31, 2016 and you must still own and live in your home on December 31, 2020; and
- You paid the full amount of the 2019 property taxes due on your home by June 1, 2020, and paid the 2020 property taxes by June 1, 2021; and
- Your total annual income must have been less than \$91,505 for 2019 and \$92,969 or less for 2020

2018 HOMESTEAD BENEFIT

Applications for the 2018 Homestead Rebate Program were mailed by the State with an anticipated delivery date of September 17th. The deadline for filing the application is November 30, 2021. 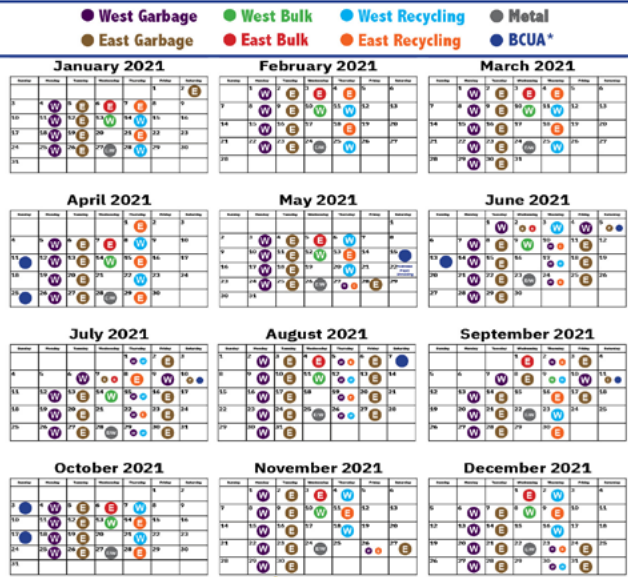

- All items should be put out *starting at 6pm the night before* the scheduled collection.
- Wood pallets are not collected by our garbage contractor. You must make your own arrangements to dispose of them.
- You must schedule a one-time, courtesy move-out pickup with TatianaMarquis@AllendaleNJ.gov at *least 3 WEEKS in advance*.
- Remember to make sure that the lids are securely on top of your cans, especially garbage. This will help keep wildlife at bay.
- Collection containers can be no larger than 30 gallons.
- Bulk Trash must be placed on the curb and **not placed** in the road.
- Food containers being recycled need to be rinsed and cleaned before you dispose.
- Soiled pizza boxes are garbage and **NOT** recyclable.

STORMWATER POLLUTION: WHAT DO YOU THINK?

- You may think littering is no big deal (it is).
- You may think that whatever runs into the storm drains gets treated before it reaches local rivers and streams (it doesn't).
- You may think motor oil and other hazardous materials don't harm the water (they do).

Pollution seeps into the ground and is carried by stormwater (rain and snow) directly to our drinking water, streams, lakes and oceans. Contaminated stormwater is the #1 cause of water pollution in New Jersey. Simple things, like proper clean-up after oneself and careful use of chemicals in the home, office and yard, are helpful ways for businesses and residents to protect the water.

Storm survivors should be aware that con artists and criminals may try to obtain money or steal personal information through fraud, scams or identity theft. In some cases, thieves try to register with FEMA using names, addresses and Social Security numbers they have stolen from survivors.

Phony Property Inspections:

- Be on alert if somebody asks for your nine-digit registration number. FEMA inspectors will never ask for this information. They already have it in their records.
- No government disaster assistance official will call you to ask for your financial account information.
- Housing inspectors never charge a fee to inspect your property.
- If you doubt a FEMA representative is legitimate call the FEMA Helpline at 800-621-3362 to report the incident.

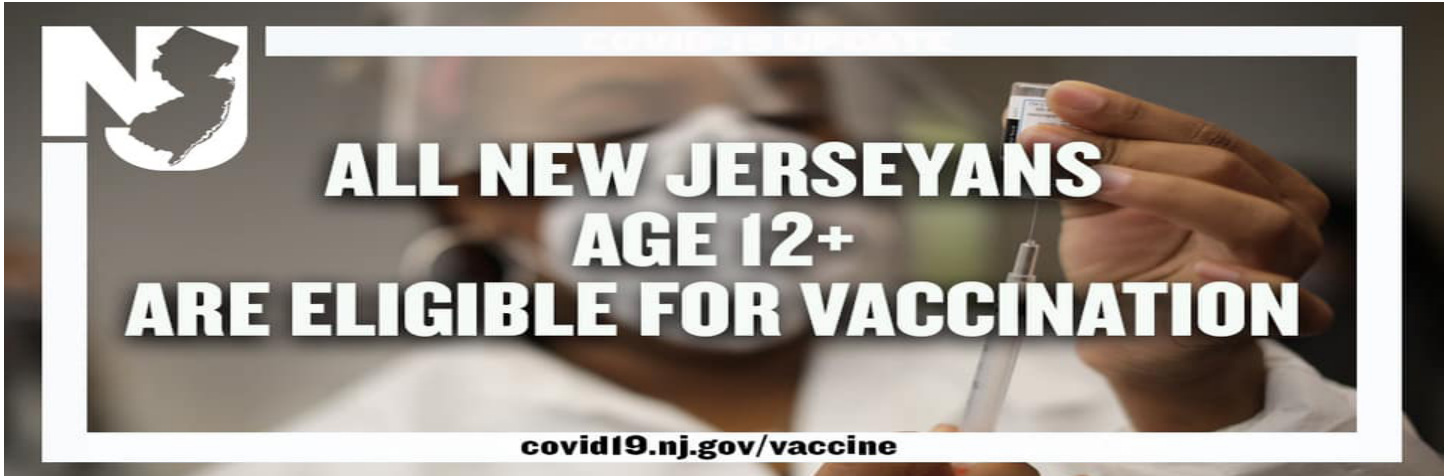
Phony Building Contractors:

- FEMA does not hire or endorse specific contractors to fix homes or recommend repairs. A FEMA housing inspector's job is to verify damage.
- Always hire a reputable engineer, architect or building official to inspect your home. An unethical contractor may create damage to get work.
- When in doubt, report any suspicious behavior to your local authorities.

FEMA Disaster Survivor Assistance:

- Federal and local disaster workers do not solicit or accept money. Don't trust anyone who offers financial help and then asks for money or personal information.
- Do not disclose information to any unsolicited telephone calls and e-mails from individuals claiming to be FEMA or federal employees. FEMA will not contact you unless you have called FEMA first or applied for assistance.
- FEMA representatives will ask for social security and bank account numbers when you apply and may ask for it again after you apply. Be cautious when giving this information to others who ask for it. Scam artists may pose as government officials, aid workers, or insurance company employees.
- Ask to see ID badges. All FEMA representatives carry an identification badge with a photograph. A FEMA shirt or jacket is not proof of identity.
