Our Emergency Services teams, led by our OEM Team, plan and train for these emergencies year-round. I want to thank our OEM Director Mike Dillon, our Police Department, volunteer Fire, and Ambulance Corps, CERT members, Director of Operations Ron Kistner, and his DPW team for all their hard work during the storms and now as they address the clean-up. Everyone in the Borough is working hard to bring Allendale back after these storms. Thank you to the residents for your patience and understanding as this work is completed.

As another example of how the hard work in the Borough continues long after a storm passes, I also want to thank OEM Director Mike Dillion and CFO Alissa Mayer for their efforts in submitting reimbursements to FEMA for 2020's Tropical Storm Isaias. They submitted \$92,316.70 in expenses of the Borough for that storm, and we were just notified that we have been awarded the customary 75% so we will be receiving approximately \$70,000. Thanks to the both of you!

This time of year marks the start of the new school year; a time of fresh starts, opportunities to learn, new experiences, and new friendships. It's always an exciting time of year! I want to wish everyone, the kids, parents, and teachers a very successful school year!

With the start of the new school year, I want to highlight the importance of pedestrian safety. Please be extra careful while driving around town. 

# GARBAGE & RECYCLING REMINDERS



- All items should be put out starting at 6pm the night before the scheduled collection.
- Wood pallets are not collected by our garbage contractor. You must make your own arrangements to dispose of them.
- You must schedule a one-time, courtesy move-out pickup with <u>TatianaMarquis@AllendaleNJ.gov</u> at least 3 WEEKS in advance.
- Remember to make sure that the lids are securely on top of your cans, especially garbage. This will help keep wildlife at bay.
- Collection containers can be no larger than 30 gallons.
- Bulk Trash must be placed on the curb and **not placed** in the road.
- Food containers being recycled need to be rinsed and cleaned before you dispose.
- Soiled pizza boxes are garbage and NOT recyclable.

# Borough of Allendale PET WASTE AND WATER POLLUTION



Borough of Allendale has adopted and enforces an ordinance that requires immediate and proper disposal of solid pet waste deposited on any property not owned or possessed by the pet owner or keeper. https://ecode360.com/8918549

Pet waste is carried by rain, melting snow, and ice to storm drains that empty into rivers, lakes, and the ocean. It also reaches reservoirs which supply much of the drinking water in New Jersey.

Pollution due to pet waste negatively impacts swimming, boating and fishing in these water bodies.

Pet waste contains microorganisms that can cause bacterial diseases, roundworms and parasitic infections.

In addition, pet waste contains harmful levels of nutrients which promote excessive algae and plant growth. This can rob the waterbody of oxygen, potentially killing all aquatic life in the area. Such nutrient pollution also causes waters to become cloudy and green.

#### Proper Pet Waste Disposal



A wide variety of emergencies may require you to evacuate your home. In some instances, you may have ample time to prepare to evacuate. But, in some situations, an evacuation must be immediate. Planning ahead ensures that you are able to evacuate quickly and safety. Identify the following: essential items to bring with you, how you will communicate with family and friends, where you will go, and how you will receive critical information from public safety officials. Public safety officials will communicate the need to evacuate through various means, including the media, social media, and mass notification platforms.

Some examples of incidents which may cause the need for evacuation are natural gas or electrical emergencies and severe weather events. Should emergency officials advise you of the need to temporarily relocate, having a plan where to go is critical. Keep in mind that some emergencies impact a relatively large geographic area, therefore planning numerous sheltering options will be helpful. Choose destinations in different directions so that you have options during an emergency. If needed, identify places to stay that will accept pets. Most public shelters allow only service animals.

Develop a family/household plan to stay in touch in case you become separated; have a meeting place and update it depending on the circumstance.

Keep a full tank of gas in your car if an evacuation seems likely. Keep a half tank of gas in it at all times in case of an unexpected need to evacuate. Gas stations may be closed during emergencies and unable to pump gas during power outages.

At times, sheltering in place may be more appropriate than a full evacuation. This is dependent on the type and expected duration of the emergency. Choose a room in your house or apartment for the shelter. The best room to use for the shelter is a room with as few windows and doors as possible. A large room with a water supply is best—something like a master bedroom that is connected to a bathroom. Should emergency officials communicate the need for sheltering in place, take the following actions:

- Close windows and exterior doors
- Turn off all fans, heating and air conditioning systems
- Close the fireplace damper
- Monitor media, social media platforms, and cell phones for updated information

As with many of my other public service announcements, communication and planning are two key takeaways. Ensure that your phone and email addresses are submitted to Allendale's mass notification platforms, Swiftreach and Constant Contact email. These platforms are used for both routine and emergency communications. Visit <u>www.allendalenj.gov</u> to provide your contact information to our databases.
